This warranty does not cover any product that has been subject to rust or corrosion, alteration or modification, accident, negligence, neglect (i.e., lack of lubrication), misuse, or alteration or removal of model or serial numbers. Powerhead warranty claims due to pre-ignition and/or detonation will not be honored.
